 Proposed Change of use and single-storey rear extension to garage to form annexe
 It was noted that a letter objecting to the application was sent to the Planning Authority
 from a neighbour and whilst the Parish Council has no objection we ask that
 consideration of the neighbour's concerns be given. We also request that should
 permission be granted, a condition is placed that the development and the land is tied to
 the existing dwelling in order to avoid it being sold as a separate dwelling.
- (ii) 19/00363 Whitehill House, Bridge Road, Lower Hardres
 TPO no 2 1973 Located to the left of the main entrance and Maple tree adjacent, cut branches back away from cables. No objection.
- (iii) Members noted that the Boundary Commission accepts the new Parish boundary for Lower Hardres and Nackington.
- (iv) Complaint from a resident re trees in Hardres Curt Road.

 A lengthy communication was received from a resident concerning the poor condition of several trees. Following discussion it was agreed the Clerk report to Highways the resident's concerns over the trees and the Chairman to respond to the resident.

 Village Green at the Junction of School Lane and Hardres Court Road, Lower Hardres,
 Application No: 18/00392 Proposal: Blue Atlas Cedar Tree 30% crown reduction and
 20% crown thin to re-balance. Removal of major deadwood from crown and pinch back
 lower lateral boughs. Following CCC's refusal to allow all of the above works to take
 place, the contractor has taken several photographs and will be sending them to CCC to
 justify the application. The Clerk to speak to the Planning Officer for clarification as to
 the current position.

The Clerk to report the following to Highways:

- The recently filled pothole in Nackington Road needs further attention.
- To report again to Highways the issue of flooding in School Lane.
- The breaking away of the sides of Merton Lane and the subsequent flooding
