#### 5. Planning Matters

(i) 19/01615 Whitehill House, Bridge Road, Lower Hardres
Proposal: TPO No 2,1973- T1 (Holly)- reduce to below previous cutting points and reshape. T2 (Yew) reduce to previous cutting point and re-shape, T3 (Garry Eliptica)reduce to previous cutting point, T4 (Bay)- trim back re-growth. T5 (Ash)- cut back
saplings to 5ft and tallest Ash reduce to previous cutting point, T6 (Cotton Poplar)repollard, T7 (Silver Birch)- reduce stems down to natural weeping stems, T8
(Laburnum)- removal of 3 lowest branches. T9 (Rowan)-removal of side stem, T10
(Hawthorn)- fell, T11(Pine)- removal of branch nearest to house, T12 (Sycamore)removal of low water shoot growth from main stem and reduce back overhang
growth from right of the entrance to road side and T13 (Rowan)- remove low growth
over garage roof.

Members supported the above application.

#### 6. Planning Decisions Granted by CCC

(i) 19/01518/LUP Willow House, Nackington Road, Lower Hardres
Application for lawful development certificate for proposed single-storey rear extension, timber cladding to ground-floor elevations, alterations to windows and doors to ground-floor and replacement canopy to front elevation following demolition of conservatory.

# 7. Highway Issues and PROW

Members agreed that the HGV traffic had been particularly bad this last weekend due to the closure of the M20 between J9 and J11. However when the M20 was re-opened early during Sunday afternoon the use of the B2068 by HGV ceased. Cllr Taylor had received absolute assurance from a KCC Highways Officer that signs were placed at J11 informing lorries not to use the B2068, but when Cllr Taylor checked, there were no signs. He will be taking the matter up with KCC Cllr Northey.

The Clerk to report that overhanging foliage is obscuring the sign advising that Bridge Road is unsuitable for HGV's.and to request a similar sign in Bridge Road by the 30mph sign.

#### 8. Broadband

Following a meeting with the KCC UKBD Manager prior to commencement of the Parish Council meeting, at which he outlined the problem and possible solution of notspots in the Parish, a notice to be placed in the Parish News asking residents of Nackington and Pett Bottom to contact a member, Chairman or the Clerk if they are experiencing problems.
