 CCC has arranged a video call meeting at 2.30pm on 19th October 2020 for Parish
 Councils to discuss the options for Concurrent Functions Funding for 2021-2022
- (iv) Coronavirus (COVID-19) Update on any issues relating to Local Councils. (i) CCC's proposals to amend Parish Councils rights to Call-in applications.

The Clerk wrote to the City Council objecting to the lack of consultation, the speed and the proposed amendment to Parish Councils' right to call-in applications and have them placed before the Planning Committee. In future Parishes will have to liaise with their Ward Councillor to make the Parish Council's point of view, thus, blocking access and communication with the officer dealing with an application. Unfortunately the result of the proposal at the City Council's Corporate Governance Meeting was carried, the voting of which was on 'party lines'.
