Minutes of the Parish Council Meeting held on Tuesday 5th April 2022

1. Apologies for Absence

Apologies were received from Cllr Moore

2. Declarations of Interest

Cllr Miss Grundy declared an interest in item 4ii Finance Payments

3. To Approve the Minutes of the Meeting held on 2nd March 2022 and Matters Arising
The minutes of the meeting held on 2nd March were approved and signed by the Chairman as a
true and correct record.

Item 7 Local Needs Housing: Unfortunately Mr Baker-White could not attend this meeting so Mr Rooke has suggested next month, however as the Chairman will be away it is suggested that we invite them both to either the May or June meeting.

Item 9 Trees around Nackington War Memorial: The Clerk enquired whether members had checked this and if a problem, who is responsible for the trees. It was noted that graffiti has been sprayed on the bin at the same location. A member agreed to report this to CCC.

Due to the confidential nature of item 4iv the press and public will be excluded from the meeting.

4. Finance Matters

- (i) To consider a request from Kent Air Ambulance for a grant Following discussion it was agreed to donate £50.00.
- (ii) Members approved the following payments:

- (iii) Members approved the draft End of Year Payment Sheet and Draft Level of Reserves
- (iv) To approve the End of Year P60 and consider notification of new pay scales back dated from April 2021 to March 2022.
 - Members approved the P60 for 2021-2022 provided by our accountants, which tallied with our end of year staffing figures.
 - The Clerk explained that each year end the National Joint Council, NALC and ALC review clerks' salary scales. Any increase in the figures is back dated to April 1st of the previous financial year. The Clerk's SCP has increased by 0.32p, multiply this by the number of hours worked per week multiplied by 52 weeks, which results in the amount of back pay due.
 - The Clerk further explained that this review has also increased the estimated staffing budget by £75.00 for 2022-23. It was proposed and seconded that both the back pay and the increase in the staffing budget are approved. On being put the motion was carried.
- (v) Draft End of Year Accounts and to approve Certificate of Exemption re Annual Audit. Members approved the draft end of year accounts and signed the Certificate of Exemption.
- (vi) Canterbury City Council Capital Grant
 The Clerk advised that we have had our application for a CCC grant approved in the sum of £1365.32. Members to re-check the appropriate locations.
- (vii) Speedwatch Equipment Grant
 The Clerk has twice requested a formal copy of the KCC Grant Application form but has still not received it. She has asked Cllr Sole to look into the matter for us.
- (viii) To amend the signatories for the NS&I account
 This item to be deferred as the Clerk needs to check the current signatories with NS&I.

(ix) Further letter to the bank re change to standing order

It was proposed and seconded that the standing order payment to Mrs SCD Shaw be amended to 1st of each month and that the payment due on 1st May 2022 be amended to include the shortfall in the April pay and thereafter, commencing 1st June 2022 to the correct payment figure until further notice.
