Minutes of the Parish Council Meeting held on Wednesday 27th September 2023

In attendance were Cllrs Jane Grundy, Mike Taylor, Adrian Beaumont, the Parish Clerk and one member of the public.

1. Apologies for Absence

Apologies were received from Cllr Mrs Fox

2. Declarations of Interest

There were no Declarations of Interest

3. To Approve the Minutes of the Meeting held on 2nd August 2023 and Matters Arising.

The minutes of the meeting held on 2nd August 2023 were approved and signed by the Chairman as a true and correct record subject to item 4v last sentence final line to read 'Cllr Taylor agreed to assist with the plan and mapping of a new website'.

Item 4i: A letter was received from Kent Surrey Sussex Air Ambulance thanking the Parish Council for their grant.

4. Finance Matters

(i) Request from the Parochial Church Council for a grant.

Copies of the invoices for last year's upkeep of the Burial Grounds were received but these do not confirm receipt of the Parish Council grant nor its specific use that it may only be put towards the upkeep of the Burial Grounds. In order to satisfy our Auditors we must be able to evidence to whom the grant was awarded and how it was spent.

Following a lengthy discussion, during which a member referred to other major expenses that are likely to be required in the future, it was proposed and seconded that we award £1000.00 for this current year to be split equally between the two Churches the letter to further inform that in future, due to the Council's rising expenses we may have to review the amount of any grant. On being put, the motion was carried.

A short time later CCC telephoned to say they had located the paper and that our Concurrent Functions Funding would be paid into to our bank account.

The Clerk advised that the latest bank statement did not show receipt of repayment of the loan. Cllr Taylor to contact Mr Marsh the Treasurer.

(v) To give consideration to expanding the website

Cllr Taylor showed a draft he had put together of a possible layout for a new website. He

5. Planning Matters

- (i) CA/23/01529 The Vines, Bridge Road, Lower Hardres.
 T.P.O. No 4/1964/LHA T1. Maple Tree, lift the low growth 25-30% crown thin and reduce the tree down to its previous cutting points (approximately a 5m reduction) and re-shape all round accordingly to the left boundary of the rear garden. T2) Beech tree reduce in the outer growth all round by approximately 2m all round, fading into the crown of the tree located in the left corner of the rear garden. T3. Sycamore, carry out a 20% crown thin and reduce the tree down to its previous cutting points (approximately a 3-3.5m reduction) together with re-shape all round accordingly to left boundary of the front garden.
