(vi) To consider estimates for 2024-2025

The Clerk took members through the budget proposed for 2024-25 during which it was agreed to include a contingency figure of $\pounds 1000.00$, a figure of $\pounds 1000.00$ for a new website, an increase of $\pounds 600.00$ in the highway fund and one or two minor figures rounding it up to $\pounds 13000.00$. Following discussion it was proposed and seconded, to recommend to the December meeting that we set a precept of $\pounds 13000.00$ for 2024-25.

- (vii) Consultation on Boundary Review and Polling Stations Review Although the review continues for some time, in view of a remark made at a boundary review public meeting regarding the new Mounts development and Nackington, the Clerk suggested we keep our eye on this.

4. Planning Matters

- (i) CA/23/01720 Farnham House, Merton Lane, Lower Hardres Single-storey detached dwelling following demolition of garage. The Design and Access statement clearly state that the proposed is an annex for the aged parents of the owners of Farnham House, which is on the market for sale. This raised Concerns, along with the siting of the three bedroom new build being too far from the main house and could be intrusive to the cottages in Stuppington Lane, the annex doors and passage ways too narrow for a wheelchair and the requirement for a condition tying the land and the two properties as one. We have since been informed that apart from our query regarding the sale of the main property have been met. However, the Clerk contacted the architect for clarification on the possible sale of the main house. She was advised that the owners wished to keep all their options open. If permission is granted Farnham House would be taken off the market.
- (ii) CA/23/01941 Great Catts Farm, Catt's Wood Road, Lower Hardres Application for Listed Building Consent for external alterations including the waterproofing of the existing brickwork with underlay and fixing a butyl liner of existing horse pond. No objection

5. Planning Decisions of Canterbury City Council

- (i) CA/23/01529 The Vines, Bridge Road, Lower Hardres.
- T.P.O. No 4/1964/LHA T1. Maple Tree, lift the low growth 25-30% crown thin and reduce the tree down to its previous cutting points (approximately a 5m reduction) and re-shape all round accordingly to the left boundary of the rear garden. T2) Beech tree reduce in the outer growth all round by approximately 2m all round, fading into the crown of the tree located in the left corner of the rear garden. T3. Sycamore, carry out a 20% crown thin and reduce the tree down to its previous cutting points (approximately a 3-3.5m reduction) together with re-shape all round accordingly to left boundary of the front garden. Approved by CCC
- (ii) CA/23/01537 Stable Cottage, Church Lane, Nackington, Lower Hardres Render to south facing gable elevations. Approved by CCC

6. Highway Issues and PROW

• Further communications have been received from a resident at Harminsole making a few suggestions to add to the HIP. He also enquired as to when Petham's 40mph limit would commence, the Clerk advised that it started the previous day, but try as they may to get it extended to Harmansole KCC Highways refused.

Following Cllr Taylor's communication to Kent Highways regarding a further cancellation of proposed works along Faussett Hill, the following reply was received:This work has been programmed several times and each time unfortunately, has been postponed.
Initially for contractual reasons, subsequently due to other network constraints taking
precedence, namely emergency SGN closure in Wincheap. Effectively this resulted in all other
work on main roads in Canterbury being postponed, this has now caused a backlog of work for
both KCC and statutory undertakers which will need to be cleared.
At this time I do not have revised date for Faussett Hill patching work, however once known we
will reschedule and send out potices and erect advance signs as normal. Additionally weather at

will reschedule and send out notices and erect advance signs as normal. Additionally weather at this time is adding to the problem. We will undertake emergency temporary repairs in order to keep the road safe in the meantime and the road continues to be subject to statutory inspections.
